All vendors must apply for a vendor's booth using this form. Do not apply directly to the City of Yonkers or the Westchester County Dept of Health. We will provide you direction on hoe to secure all the permits you will need to participate.

VENDOR GUIDELINES

- Vendors will be assigned a booth location and given instructions prior to the event via email. Locations are NOT negotiable.
- 2. Set-up starts at 8:00 AM, must be completed by 11:00 AM. Selling can take place from 12pm to 7pm. At 7pm all sales must stop. Vendor goods must bebroken down and removed by 7:30PM.
- 3. No Amplified sound of any type. You cannot interfere with Stage Entertainment.
- 4. All VENDORS MUST display a copy of their photo ID, copy of your <u>NYS Vendor Certificate of Authority</u>, Beer and food permits.
- 5. If you are a FOOD vendor you MUST display a copy of your Westchester County Mobile Health Permit or completed Westchester County Temporary Food Service Application or catering license.
- 6. If you are a NON-PROFIT You MUST provide a copy of your 501(c)3.
- 7. DO NOT mail your application to the City of Yonkers. All Yonkers Puerto Rican / Hispanic Festival vendor applications and permits will be obtained through the YHCF and this application.
- 8. All Vendor Forms and Fees MUST be submitted by May 17, 2025.
- Vendors must complete the City of Yonkers Vendor application which is attached to this application. The City Vendor fee will be paid by the YHCF as part of your application fee to participate.
